2019 BCA Market Commentary

- Capital markets in HCIT in 2019 saw a dramatic surge in IPO activity, with Change Healthcare, Phreesia, Livongo and Health Catalyst all going public. Private equity activity saw continued interest in specialty-specific clinical software, with the recapitalizations of companies like WebPT (physical therapy), Qualifacts and Credible (behavioral health) and Orchard Software (laboratory).
- At the JPM Healthcare Conference in San Francisco, broad conversations suggest continued optimism for the HCIT sector, with many of the same themes and focal areas continuing to be of interest, including payer solutions that drive payment integrity and workflowefficiency, RCM solutions tailored to the complex claims space, technologies that remove excess cost from a health system fraught with waste and clinical software tailored to specific end-market workflows.
- BCA's activity in 2019 mirrored many of the broader market themes with a total of five HCIT transactions closed in the payer enrollment, data archiving and management, laboratory and dental practice management sectors.
