## **1Q22** Healthcare Technology Sector Overview



### BCA Market Commentary & Stock Indices Relative Performance

- Care navigation was a recurring HC Tech theme in 1Q22. The recent shift to high-deductible health plans has prompted many employers and TPAs to adapt solutions that simplify and streamline decisionmaking by patients across the continuum of care. Two examples are the merger between Castlight and Vera, financed by CD&R, and the acquisition of Midas by Symplr.
- Provider connectivity is another area with ongoing activity as providers adapt to a value-based delivery model in which care is delivered across a continuum, a recent example being PointClickCare's acquisition of Audacious Inquiry.
- The revenue cycle management sector remains active, as providers struggle under payment complexity and limited resources and increasingly look to outsource these functions. Examples include CPSI's acquisition of RCM player HRG, and Berkshire Partners/ Warburg Pincus's recapitalization of Ensemble Health.
